RE: Invitation to Participate in Consultation Session on the Review of the Limpopo Tourism Growth Strategy (TGS)

Limpopo Economic Development, Environment & Tourism (LEDET) has the mandate to promote a competitive economy, ensure sustainable environmental management, and grow the tourism sector in the province. To achieve this, LEDET focuses on accelerating economic growth, creating employment, managing environmental resources, and making Limpopo a preferred tourism and investment destination.

In fulfilling its mandate to grow tourism, the department has a focus on the following:

- Promoting and managing tourism activities in the province.
- Positioning Limpopo as a preferred tourism destination.
- Developing sustainable tourism destinations.

- (c) Identify key strategic projects for the tourism sector.

Millvest Advisory has been appointed as the service provider for this review and will be working closely with LEDET to ensure that the TGS review is conducted efficiently and effectively.
